# MINUTES OF THE REGULAR MEETING OF THE WALHALLA CITY COUNCIL January 18, 2022, 5:30 PM

**Present**- Mayor Danny Edwards, Mayor Pro-Tempore Danny Woodward, Administrator Brandon Burton, Councilman David Underwood, Councilwoman Sarai Melendez, Councilman Keith Pace, Councilman Grant Keehn, Councilman Tyler Jordan

Absent: Councilwoman Sarai Melendez

Guests: Media. Other Staff.

Mayor Edwards called the meeting to order at 5:30 PM.

Mayor Edwards led the moment of silence.

Councilman Jordan led the Pledge of Allegiance.

Mayor Edwards called for the approval of the council meeting minutes for 11/16/2021, 12/7/2021, and 12/21/2021. Councilman Pace made the motion and Councilman Woodward seconded. There were no changes or discussion. All present voted in favor.

Mayor Edwards called for public comment. Mayor Edwards went over rules of meeting as it pertained to public comment.

Jim Aguilera, from Walhalla and business owner of Trailhead Tavern, is requesting approval for the Trailhead Tavern sign to replace the old Backstreet Burgers sign. He further requests approval for a wooden sign reading Trailhead Tavern to be posted on the side of the building, facing the parking lot. Mr. Aguilera has submitted photos for approval. Elijah Hayes addressed the council and informed them that the sign is conformed to the ordinance, but it is a freestanding sign, and will require approval from the city council. Mr. Woodward made a motion to approve, Mr. Pace second. Mayor called for discussion and vote. All voted in favor.

Administrator Burton moved forward with administrator comments announcing Mr. Will Bates as the appointed new Fire Chief for Walhalla. Mr. Burton discussed the overage bill from the Sewer Authority and informed everyone that the bill was recalculated, and we do not owe anything above our normal monthly expense. He hopes to have RFP discussion and approval at the next council meeting. Mr. Burton thanked the staff for all the work they did during the snowstorm with power outages and road safety. He announced that the grant for Stumphouse was approved, and we should be able to complete phase 3 on the extra 10 miles for the mountain bike trail and probably fund the parking lot at Ross Mountain. Lastly, Mr. Burton discussed the committee make up and need for changes to be updated.

Mayor Edwards resumed meeting stating there were no proclamations or resolutions. There are a couple of ordinances for second and final readings.

Councilman Pace gave final reading on Ordinance 2021-33 to amend Zoning Ordinance 2021-17 to redesignate parcel 500-14-17-003, 500-14-17-004, 500-14-17-005, and 500-14-17-006. Mr. Pace made motion, Mr. Keehn second. Mr. Keehn requested discussion to help everyone understand the details of the ordinance. Mr. Burton explained details. Mayor called for discussion and vote. All voted in favor.

Councilman Pace gave final reading on Ordinance 2021-34 to amend Zoning Ordinance 2021-17 to incorporate a color palette into the design guidelines. Mr. Pace made motion, Mr. Woodward second. Mayor called for discussion and vote. All voted in favor.

Councilman Keehn gave first reading of Ordinance 2022-1 to issue amendment 4 to amend FY2022 budget and Appendix A and other related matters. Mr. Keehn further discussed why it is necessary for the sewer and water rates to be raised. Mr. Keehn made a motion, Councilman Jordan second. Administrator Burton explained the details and made recommendations for water rate increase. Mr. Scott Parris added to explanation. Following discussion, Councilman Pace made and amendment and a motion for a base rate adjustment for water rates, Councilman Jordan second. Mayor called for discussion and vote on the amendment and, separately, the amended motion. All voted in favor.

Administrator Burton discussed the sewer rates and gave detailed explanation regarding the rate increases. The Sewer Authority increased rate 20%. Mr. Burton explained the reason for additional 20% increase in addition to the SA increase, totaling 40% increase. Discussion continued amongst councilmembers. Mayor Edwards voiced that he is not in support of the 20% increase before the Sewer Authority does their 20% increase. Mayor Edwards wants to look at the numbers before it goes to a vote. Discussion continued amongst councilmembers and Scott Parris. Councilman Keehn made a motion to raise sewer rates to the 40%, Councilman Jordan second.

Previous motion withdrawn. A motion to reconsider the originally discussed plan for water and 40% increase for sewer was made by Councilman Keehn, Mayor Pro-Tempore Woodward second. Mayor called for discussion and vote. All voted in favor.

Administrator Burton shared advice from the city attorney, Mr. Kozlarek, stating that he would like for the council to formally vote and accept the FY 2021 audit. Councilman Pace made the motion that the audit be accepted as written, Councilman Jordan second. Mayor called for discussion and vote. All voted in favor.

Administrator Burton opened discussion regarding the open container ordinance. Discussion was had between councilmembers and Chief Sean Brinson. Everyone agreed this topic needs to be further discussed and is not ready for a formal vote, yet.

Administrator Burton announced Mrs. Rosemary Bailes resignation from the Planning Commission. Mr. Burton added that he does have one person interested and asked how those board seats were filled in the past. Mr. Pace explained that it was done by nomination. Discussion continued amongst councilmembers.

Committee Reports were given by respective department heads from the January 4, 2022 meeting.

Mayor Edwards called for continuing meeting in Executive Session to discuss legal advice on pending litigation. Councilman Pace made the motion, Councilman Underwood second.

Following Executive Session, Mayor Edwards called for motion to adjourn. Mr. Underwood made the motion, Mr. Pace second.

WHEREAS, the Walhalla City Council adopted Ordinance 2021-8 entitled "AN ORDINANCE TO RAISE REVENUE AND ADOPT A BUDGET FOR THE CITY OF WALHALLA, SOUTH CAROLINA, WATER AND SEWER DEPARTMENTS FOR FISCAL YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022 and;

WHEREAS the Walhalla City Council adopted Ordinance 2021-6 entitled "AN ORDINANCE TO RAISE REVENUE AND ADOPT FOR THE CITY OF WALHALLA, SOUTH CAROLINA A BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022 and;

WHEREAS, the Walhalla City Council is authorized to approve funding and to amend budgeted expenditures as required to meet and maintain the fiscal obligations of the City of Walhalla; and

WHEREAS, the Walhalla City Council has reviewed the projected expenditures for fiscal year 2022, and has identified a need to adjust revenues for the enterprise funds to meet general obligations and debt service; and

WHEREAS, the amendment is made part hereof as fully as if incorporated herein and a copy thereof is hereto attached and also be known as the current approved fiscal year budget document and;

WHEREAS, the Walhalla City Council now would like to amend the FY 2022 Budget Document, Appendix A; adjusting fees water and sewer funds and;

AN ORDINANCE TO AMEND ORDINANCE 1976-5 AN ORDINANCE TO AMEND SECTION 22-85, PROHIBITING THE POSSESSION IN OPEN CONTAINERS AND CONSUMPTION OF WINE, BEER, ALE, PORTER OR OTHER SIMILAR MALT OR FERMENTED BEVERAGES IN PUBLIC AREAS OF THE CITY OF WALHALLA AND OTHER MATTERS RELATED THERETO

BE IT ORDERED AND ORDAINED by the Governing Body of the City of Walhalla in Council duly assembled and by the authority of the same:

SECTION 22-85, of the Ordinances of the City of Walhalla, is hereby amended, in toto, so as to read as follows:

SECTION 22-85(A): It shall be unlawful for any person to drink or to have in their possession in an open container beer, ale, porter or other similar malt or fermented beverages containing not in excess of five per cent of alcohol by weight, or wine containing not in excess of twenty-one per cent of alcohol by volume on any public street, sidewalk, alleyway, park, playground or other public place within the Corporate Limits of the City of Walhalla.

SECTION 22-85(B): Public places as defined by this Ordinance

shall include, but is not limited to, any business, store, office or structure to which the public is invited to conduct business or to visit, including parking lots adjacent thereto, unless same has been lawfully licensed to sell such beverages or unless the same has received from The South Carolina Alcoholic Beverage Control Commission a license to allow on-premises consumption of alcoholic beverages, beer, or wine. Exceptions to this are current sidewalk encroachment permits as defined by Ordinance 2014-8 and/or permitted events as defined by Ordinance 2021-23.

SECTION 22-85(C): It shall be a violation of this Ordinance for any person or persons to drink or consume any beer, wine, malt liquor, or other such alcoholic beverages or to have in their possession an opened container of same, while a passenger in any motor vehicle of any kind situate upon or using the public streets or any public place of the City of Walhalla, unless such public place is lawfully licensed to sell such beverages or unless the same has received from The South Carolina Alcoholic Beverage Control Commission a license to allow on-premises consumption of alcoholic

beverages, beer or wine.	

SECTION 22-85(D): Any person violating this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined not more than One Hundred Dollars (\$100.00) or imprisoned for not more than thirty (30) days.

II

This Ordinance shall take effect immediately upon adoption and ratification by the City of Walhalla, and all other Ordinances, or parts of Ordinances, inconsistent with this Ordinance, as amended, are hereby repealed.

## AN ORDINANCE TO AUTHORIZE THE SERVICE AND CONSUMPTION OF BEER AND WINE IN SIDEWALK ENCROACHMENT AREAS

WHEREAS, the city of Walhalla wishes to provide restaurateurs with the option to sell beer and wine for consumption on public sidewalks contiguous to an establishment otherwise licensed to serve and sell beer and wine for on premises consumption and having valid written authorization from the local political subdivision having jurisdiction over the location; and

WHEREAS, City Council has reviewed the existing practice, the revised Department of Revenue regulation, and the prevailing practices of other municipal governments in the state and has also heard from those who advocate the benefits of beer and wine service in encroachment areas for purposes of personal enjoyment and municipal economic development; and

WHEREAS, City Council has also reviewed the impact of the service of beer and wine in encroachment areas upon night time public safety and noise in the Central Business District and has concluded that the public safety of the City is promoted by ceasing all beer and wine service and consumption in encroachment areas after midnight;

## **NOW THEREFORE**

## **BE IT ORDAINED**

BY THE MAYOR AND CITY COUNCIL OF THE CITY OF WALHALLA, SOUTH CAROLINA:

**SECTION 1.** The Ordinance of the city of Walhalla shall authorize the sale and consumption of beer and wine (poured and served in clear plastic cups) in sidewalk areas having a validly issued encroachment permit for the service of food and beverages and (b) limit the hours during which beer and wine, may be served and consumed in an encroachment area to the **hours** between **ten o'clock a.m. and midnight.** 

SECTION 2. Any restaurateur who has a permit authorizing the sale and consumption of beer and wine for on premise consumption and wants to provide such service in sidewalk areas having a validly issued encroachment permit for the service of food and beverages, must furnish to the city of Walhalla, a policy of insurance in the amount of one million (\$1,000,000.00) dollars combined single limit bodily injury and property damage liability insuring the business establishment against any hazard which might occur by reason of the sale of beer and wine in sidewalk areas and must execute an agreement to hold the city of Walhalla harmless from any litigation of any manner or form by reason of the sale of beer or wine in sidewalk areas within the city of Walhalla.

SECTION 3. This Ordinance shall become effective for all encroachment permits issued after June 17, 2014.

## **ORDINANCE 2008-1**

AN ORDINANCE TO AMEND ORDINANCE 2003-11, REGULATING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES, ANY WINES, MALT LIQUORS OR BEER IN ANY STORE OR OTHER PLACE OF BUSINESS IN THE CITY OF WALHALLA.

SECTION I. It shall be unlawful for the owner or person in charge of any store, beer parlor or other places of business or commercial establishments to sell, give away, or in any manner dispense, or permit the consumption of any wines, malt liquors or beer in such store, beer parlors or other places of business or commercial establishments, including premises, between the hours of MIDNIGHT and 7:00 AM with the exception of New Years Eve, the hours will be between 1:00 AM and 7:00 AM. If New Years Eve falls on either Saturday or Sunday, the city will follow the State's Blue Law.

SECTION II. PRIVATE ESTABLISHMENT/CLUB: It shall be unlawful for the owner, operator or any employee of any private establishment/club, located inside the city limits of Walhalla, South Carolina to serve, sell, give away, or in any manner dispense, or permit the consumption of any alcoholic beverages, wines, malt liquors or beer between the hours of 2:00 AM and 7:00 AM. All occupants including owner, bartenders and waitresses must be out of the establishment by 2:00 AM, no exceptions.

To be considered for extended hours, under a private license, the establishment/club must have been in business for twenty-four (24) months with no problems. The Walhalla Fire Chief and the Walhalla Police Chief must sign off on the premises.

SECTION III. Any person violating the provisions of this Ordinance shall be fined or imprisoned within the discretion of the Municipal Court of the City of Walhalla.




# City of Walhalla Ordinance 2014-8 Conditions of Permit

## Service and Consumption of Beer and Wine in Sidewalk Encroachment

The permit required by this article shall be issued only to permittee submitting form and other deemed appropriate information. The permit contains the following conditions:

- 1) Each permit shall be subject to annual renewal, unless revoked, suspended or retracted prior to expiration.
- 2) The permit issued shall be personal to the permittee only and shall not be transferable in any manner.
- 3) The permit may be suspended by the administrator when necessary to clear the public property for public safety for a community or special event authorized by a permit issued by the city.



- 5) The permit shall be specifically limited to the area directly in front of restaurant, and not interfere, obstruct or hamper ease of movement on sidewalk. As a condition of approval, the city may reduce and otherwise reconfigure the proposed area and the number of requested chairs, tables, and items within the encroachment area.
- 6) The encroachment area covered by the permit shall be maintained in a neat and orderly appearance at all times, and the area shall be cleared of all debris on a periodic basis during the day, and again at the close of each business day.
- 7) No advertising is permitted on any stand or item.
- 8) No tables or chairs or any other parts of the business shall be attached, chained or in any manner affixed to any tree, post, sign or other fixtures, curb or sidewalk within or near the permitted





area in a manner which causes or threatens to cause injury to any person or damage to public or private properties. No additional outdoor seating authorized under this article shall be used for calculating seating requirements pertaining to location of, application for issuance of an ABC license for any establishment, or be used as the basis for computing required seating for restaurants and dining rooms, or as grounds for claiming exemption from such requirements under the provisions of any city ordinance or state law.

- 9) The issuance of a permit does not grant or imply vested rights to use of the area by the permittee. The city retains the right to deny the issuance of a permit or the renewal of a permit for any reason.
- 10) Tables, chairs, umbrellas and any other objects provided shall be maintained with a clean and attractive appearance and shall be kept safe and in good repair at all times.



- 11) The city retains the right to suspend the privilege of using glass containers within the encroachment areas and only the use of clear plastic cups are allowed.
- 12) Any violation of State and local laws will result in a revocation of this privilege. Repeated offenses may result in revocation or denial of the encroachment permit.
- 13) The service and consumption of beer and wine on city sidewalks and public property is authorized to the extent provided for in each individual permit issued, but not otherwise.
- 14) The service and consumption of food, nonalcoholic beverages, and beer and wine in sidewalk encroachments pursuant to this article is limited to patrons seated at tables.
- 15) No encroachment permit shall authorize either the service or consumption of beer and wine between the hours of midnight and ten o'clock A.M.
- 16) The city may require the posting or placement of the permit and relevant notices to facilitate the administration and enforcement of this article.





- 17) The restaurateur who has a permits authorizing the sale and consumption of beer and wine for on premises consumption must furnish to the City of Walhalla, at the time the encroachment permit is obtained, a policy of insurance in the amount of one million (\$1,000,000.00) dollars combined single limit bodily injury and property damage liability insuring the business establishment against any hazard which might occur by reason of the sale of beer and wine in sidewalk areas.
- 18) The restaurateur must execute an agreement to hold the City of Walhalla harmless from any litigation of any manner or form by reason of the sale of beer or wine in sidewalk areas.

## AN ORDINANCE TO AMEND ORDINANCE 1976-9 "POLICE DEPARTMENT" AND OTHER MATTERS RELATED THERETO

#### POLICE DEPARTMENT

**SECTION I.** Composition appointment term of office and compensation. The police department of the City of Walhalla shall consist of a chief and such other number of policemen as the Council may from time to time determine necessary to provide adequate police protection for the City. The Chief of Police and all policemen of the Department shall be appointed by the Council City Administrator and Chief of Police respectively and shall hold office for the period of time as is provided by the City Council Administrator and shall receive such compensation for the performance of their duties as the Council administrator may from time to time designate.

**SECTION II. Powers and duties generally.** All members of the Police Department shall be invested generally with all the powers, duties and responsibilities of constable within the corporate limits of the City of Walhalla, or its police jurisdiction and such other powers, duties and responsibilities as may be from time to time conferred upon them by the Council and the South Carolina General Assembly. It shall be the duty of every policeman to enforce all provisions of this Code and perform such other duties as the Council may designate.

**SECTION III.** Chief to be Commander of police force; acting chief. The Chief of Police shall at all times be recognized and respected by members of the Police Department as their commander and superior officer, and they shall obey all orders of the Chief. In the event of the temporary absence or disability of the Chief, the Council City Administrator shall appoint an acting chief who shall have all the powers, duties and responsibilities of the Chief.

**SECTION IV. Posse comitatus.** The policemen of the City, whenever necessary in the discharge of their duty, shall have authority to call the "posse comitatus" of the City to their assistance. Any person who may be so called to the assistance of any policeman shall respond to such call and render such lawful assistance as may be required. It shall be unlawful for any person to fail, neglect or refuse to respond to any such call when made.

SECTION V. Suspension/Removal of Chief; of the policemen; final determination by Council. The Mayor City Administrator may peremptorily suspend and/or remove the Chief of Police for neglect of duty or failure to perform any duty of his office cause. The Chief of Police may likewise suspend any member of the Department. All such suspensions shall be reported to the Council administrator or city clerk within twenty-four (24) hours. who shall either affirm or revoke such suspension. The Council Chief of Police may, at any time, remove any member of the Department from office for cause.

**SECTION VI. Resisting or interfering with policemen.** It shall be unlawful for any person in any manner to hinder, impede, resist arrest or otherwise interfere with any police officer of the City of Walhalla while in the discharge of his duties either by words, signs, actions or otherwise.
