
WHEREAS, the Walhalla City Council now would like to amend the FY 2022 Budget Document, Appendix A; adjusting fees for the water enterprise fund and;

- 1" water taps (outside city) \$2200.00

**AN ORDINANCE TO ISSUE AMENDMENT NO. 4 TO AMEND THE FY 2022 BUDGET DOCUMENT AND "APPENDIX A" AND OTHER MATTERS RELATED THERETO**

WHEREAS, the Walhalla City Council adopted Ordinance 2021-8 entitled "AN ORDINANCE TO RAISE REVENUE AND ADOPT A BUDGET FOR THE CITY OF WALHALLA, SOUTH CAROLINA, WATER AND SEWER DEPARTMENTS FOR FISCAL YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022 and;

WHEREAS the Walhalla City Council adopted Ordinance 2021-6 entitled "AN ORDINANCE TO RAISE REVENUE AND ADOPT FOR THE CITY OF WALHALLA, SOUTH CAROLINA A BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2021 AND ENDING JUNE 30, 2022 and;

WHEREAS, the Walhalla City Council is authorized to approve funding and to amend budgeted expenditures as required to meet and maintain the fiscal obligations of the City of Walhalla; and

WHEREAS, the Walhalla City Council has reviewed the projected expenditures for fiscal year 2022, and has identified a need to adjust revenues for the enterprise funds to meet general obligations and debt service; and

WHEREAS, the amendment is made part hereof as fully as if incorporated herein and a copy thereof is hereto attached and also be known as the current approved fiscal year budget document and;

WHEREAS, the Walhalla City Council now would like to amend the FY 2022 Budget Document, Appendix A; adjusting fees water and sewer funds and;

NOW THEREFORE: it is ordained and enacted that: by the Mayor and Council members of the Municipality of Walhalla, in Council assembled, that the following fee schedule adjustments for the fiscal year commencing July 1, 2021, and ending June 30, 2022, shall be as follows:

1. The fees for water sales are as follows:



Apartment Inside City	\$18.00	\$3.31
Apartment Outside	\$35.00	\$5.10
Residential Inside	\$18.00	\$3.31
Residential Outside	\$35.00	\$5.10
Business Inside	\$18.00	\$3.31
Business Outside	\$35.00	\$5.10
Industrial Inside	\$49.39	\$1.59
Industrial Outside	\$80.00	\$2.50
Farm (first 40,000 gal)	\$ -	\$ 85.00
Farm (per 1000 gal)	\$ -	\$ 2.07
Municipal (first 25,000 gal)	\$ -	\$ 100.00
Municipal (per 1000 gal)	\$ -	\$ 2.25
Sprinkler (un-metered per 100 sf)- Inside City	\$ -	\$ 0.10
Sprinkler (un-metered per 100 sf)- Outside City	\$ -	\$ 0.10

2. The fees for sewer charges are as follows:

Business Outside	\$8.40	\$8.40
Industrial Outside	\$12.00	\$7.50
Industrial Outside- SO	\$12.00	\$7.50

This Ordinance shall be effective immediately upon final reading and be made a part of the official budget documents adopted June 15, 2021, for the fiscal year commencing July 1, 2021 and ending June 30, 2022.
