**AN ORDINANCE TO ISSUE AMENDMENT NO. 1 TO AMEND ORDINANCE #2024-11, THE CITY OF WALHALLA BUDGET FOR FISCAL YEAR 2024-2025, AS ADOPTED JUNE 18, 2024 AND OTHER MATTERS RELATED THERETO**

**WHEREAS**, the City of Walhalla, a body politic and corporate and a political subdivision of the State of South Carolina (the "City"), acting by and through its City Council (the "City Council") has previously adopted City of Walhalla Ordinance # 2024-11, the City of Walhalla FY24-25 Budget Ordinance (the "Ordinance"), to raise revenue and adopt a budget for general, water, sewer and hospitality funds; and,

**WHEREAS**, the Walhalla City Council is authorized to approve funding and to amend budgeted expenditures as required to meet and maintain the fiscal obligations of the City of Walhalla;

**WHEREAS**, the Walhalla City Council has reviewed the projected expenditures for Fiscal Year 2025 and has identified a need to adjust appropriations between departments and provide supplemental appropriations,

**WHEREAS**, the Walhalla City Council wishes to amend the FY 2025 Budget Document;

**NOW, THEREFORE**, be it ordained by the City of Walhalla Council, in meeting duly assembled, that the following budget adjustments shall be as follows:

1. Special Revenue: Police Station through a SC Department of Public Safety appropriation of \$4,250,000.
2. Hospitality Tax (HTAX): Amend revenues by \$60,000 to \$370,000.
3. Hospitality Tax (HTAX): Amend expenses by \$60,000 to \$370,000.
4. Should any portion of this Ordinance be deemed unconstitutional or otherwise unenforceable by any court of competent jurisdiction, such determination shall not affect the remaining terms and provisions of this ordinance, all of which are hereby deemed separable.
5. All orders, resolutions, and enactments of City of Walhalla Council inconsistent herewith are, to the extent of such inconsistency only, hereby repealed, revoked, and rescinded.
6. This ordinance shall take effect and be in full force and effect from and after second reading and enactment by City of Walhalla Council.
