

## **City of Walhalla, South Carolina Use of Facility Form**

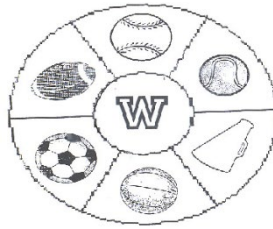

The City of Walhalla is not responsible for the activities held on the premises and the user(s) thereof specifically agrees to and do hold the City of Walhalla, its agents and employees, harmless for any use, damage or accident which occurs within the use period.

### **RESTRICTIONS**

1. All individuals and/or groups using the facility must obey all laws of the State of South Carolina and ordinances of the City of Walhalla.
2. No alcoholic beverages may be consumed on the premises nor brought onto the premises.
3. No tobacco products, including but not limited to cigarettes, cigars, pipes, smokeless tobacco and snuff, or alternative nicotine products may be used on the premises, indoor or outdoor.
4. No pets will be allowed on the premises.
5. No profanity or abusive language.
6. No fighting, rough play, or inciting a riot.
7. Individuals making reservations shall be held responsible for any damages to the premises and/or equipment and shall make payment for the repair or replacement within ten (10) days of receipt of the statement of costs.
8. No loud noise and/or music shall be permitted which shall constitute a nuisance as determined by the Chief of Police or his designated representative.
9. Users will leave the premises clean of debris. All debris must be placed in trash receptacles.
10. Athletic teams must provide proof of liability insurance with the City of Walhalla listed in coverage.
11. City of Walhalla reserves the right to end a rental agreement at any time.
12. City of Walhalla reserves the right to charge a \$100 clean-up fee.
